I am fully aware & acknowledge that horse sports and the competition involve inherent risks of accident, loss, and serious bodily injury including broken bones, head injuries, trauma, pain, suffering and/or death ("Harm"). Under the Equine Liability Act, each participant who engages in an equine activity expressly assumes the risks of engaging in & legal responsibility for injury, loss, or damage to person or property resulting in risks of equine activities. I agree to release Barrington Hill, Alicia Trias Padro, any staff, & the Competition from all claims for money damages or otherwise for any Harm to me or my horse and for Harm caused by me, or my horse to others, even if Harm resulted, directly or indirectly, from the negligence of the competition. I agree to expressly assume all risks of Harm to me, or my horse, including Harm resulting from negligence of Barrington Hill or the Competition. All junior riders MUST wear approved helmets with chin traps securely fastened while mounted and all riders MUST wear helmets while mounted on a horse/pony. I understand that under the Equine Activity Liability Act, each participant who engages in an equine activity assumes the risks of engaging in and legal responsibility for injury, loss, or damage to person or property resulting from the risk of equine activities. If I am a parent of a junior exhibitor, I consent to the minor's participation & AGREE to all of the above provisions & AGREE to assume all of the obligations of this Release on the minor's behalf. I represent that I have the requisite training, coaching & abilities to safely compete in this competition.
